**Live Cover**

Mare owner agrees to pay for care and feeding while in the custody of the Stallion owner at a rate of **\$25 per day for a dry mare, \$35 per day for a wet mare**. Mare owner shall pay the breeding fee, mare care, and any fees owed prior to the mare departing the Stallion Owner’s property. Mare Owner agrees that the mare shall be in healthy and sound breeding condition, have a negative uterine culture, provide current shot records (including EHV vaccination within 30 days) and negative coggins, and will provide in writing any known health risks/circumstances which may be relevant to the care of said mare during the period of the performance of this contract. Mare must be easy to handle and accepting of breeding hobbles. Stallion owner reserves the right to refuse covering a mare that kicks or is aggressive towards stallion without reimbursement of deposit and mare care still owed.

General Conditions:

1. This contract contains a “Live Foal Guarantee”. A live foal is described as a newborn foal, which stands and nurses without assistance. If foal is born dead, there are return privileges for the following breeding season only if Breeder is notified within 5 calendar days. If after being pronounced “safe in foal”, should the mare miscarry, abort or prove barren, Mare Owner has the privilege to return her for breeding during the current breeding season or the following year. Mare owner shall be responsible for all costs associated with rebreeds. **There will be a \$200 Rebreed Fee for rebreeds the following year.**

2. A “Breeders Certificate” will be issued for the foal conceived by this mating when stallion fee and all other expenses have been paid in full and there is a heartbeat confirmation from vet.

3. Should the stallion die, be sold by the owner, or become unfit for service prior to settling the mare, all deposits or breeding fees will be fully refunded.

4. This Contract is non-assignable and nontransferable. This Contract is entered into in the State of Wyoming and will be interpreted and enforced under the laws of that state. This Contract represents the entire agreement between parties. No other agreements or promises, verbal or implied, are included unless specifically stated in this written Contract. When Mare Owner and Breeder sign this Contract, it will then be binding on both parties.
